916 Ink is Sacramento's arts-based creative writing nonprofit, with a mission to "empower youth through creative writing." This is a simple mission statement, with powerful impact. In addition to our mission, we apply our core values to every aspect of our work. These values are:

- *Empathy* We cultivate an open and compassionate environment.
- *Empowerment* We encourage each individual to step into their own power.
- Equity We commit to justice and advancing the unique experience and expression of all.
- *Octopus* We celebrate creativity, bravery, and risk-taking.

Through this work, we seek to transform the youth of Sacramento into confident writers and published authors, increasing literacy skills, improving vocabulary, teaching empathy, positively impacting social and emotional learning, and expanding communication skills.

What does the organization do to achieve the mission?

Sacramento County is facing a literary crisis. According to the 2018 California Assessment of Student Performance and Progress (CAASPP) standardized test results, over half (53 percent) of Sacramento County students in grades 3-8 did not meet the achievement standard in English Language Arts and Literacy. Some students fare even worse, such as those living in poverty, those involved in the juvenile justice system, adolescent parents, foster youth, and youth experiencing homelessness.

916 Ink takes an approach to this crisis that is unique in Sacramento. Through innovative and engaging creative writing and storytelling workshops, we fill a critical need for literacy skill-building while simultaneously empowering youth, building their self-esteem, encouraging their social-emotional growth, and fostering a lifetime love of reading, writing, and learning.

916 Ink's strengths-based approach is proven to have a profound impact on self-esteem, writing confidence, personal achievement, and overall academic engagement. When a young person's unique voice is unlocked, they begin to understand their life as a narrative that can be changed. They don't have to be the antagonist, victim, or bystander in their own story-- they can be their own champion. It is impossible to instill a genuine interest in literacy without engaging youth in storytelling and empowering them to give voice to their own stories. We build a bridge for youth – helping them shift from an attitude of self-defeat to one of resiliency. In addition, our participants experience emotional health gains as they find their voice, express and process difficult circumstances, and are celebrated for sharing their stories and the publication of their book.

COVID-19 has impacted the way that we implement our programs, but it has not slowed us down. Since the shelter-in-place order was issued in March, we have worked with 250 students through our Summer Camps and Virtual Creative Writing sessions. This represents the largest number of summer participants in the history of our organization. This fall we have at least a dozen virtual programs lined up, including our after-school drop-in workshops and various school-based programs. Additionally, since the start of the pandemic, we have launched new offerings like Ink TV, a weekly YouTube show for youth in grades 3rd-6th, an online library of prompts, a weekly newsletter to help parents guide their young writers at home, and more. Due to the COVID-19 pandemic young people are living through trauma. As students are challenged to navigate rapid and massive changes, 916 Ink is working to provide positive ways for them to process this experience. Virtual offerings will remain part of what we provide in the future, as this improves access for some who may not have been able to interact with 916 Ink in the past.

At 916 Ink, we are committed to reaching the youth in Sacramento who we believe need our work the most. We work with all populations, but have a special focus on low-income and minority youth, as well as those involved in the criminal justice system. For example, we focus outreach efforts on neighborhoods within the "Sacramento Promise Zone," those 22 square miles of Sacramento that have been designated as "most underprivileged" by the City of Sacramento and the U.S. Federal Government. We have made an intentional effort to recruit facilitators that reflect the populations we work with, as well as populations we hope to attract more of. For example, we recognize that boys and young men of color may respond best to a workshop facilitator who is also a young man of color; to better serve this population, we prioritized hiring facilitators from this community. Additionally, we publish our resources in Spanish alongside English and have one fully bilingual (Spanish/English) facilitator. Actions like these mean that we can more equitably and effectively serve our community and reach the most vulnerable children. We believe deeply that our work is transformative, that showing vulnerable youth that their voices matter will have long-lasting impact on their/our community and our larger world.
