UUSS Treasurer's Report - July 2022 September 22, 2022

A. FISCAL YEAR NET INCOME

July was the first month of the 2022-2023 fiscal year, so the year-to-date figures represent the totals for the year.

UUSS had a net gain of \$24,259 in July. Revenues were \$21,828 more than budgeted and expenses were \$2,431 below budget.

- 1. Income items of interest:
 - **a.** Total pledge receipts were \$66,157, \$18,241 over projections.
 - i. Pledge receipts are always high in July as people pay their new pledges in lump sums.
 - **b.** Building Rental Income was \$2,238 more than projected. Rentals are increasing due to the reduced concern about the pandemic.
- **2.** Expenditures items of interest:
 - a. Expenses in most categories were either at or below budget..

- **C. Cash Flow:** Cash flow (ability to pay bills) is not a concern currently, as the operating fund balance is \$209,905.
- D. July 31, 2022, Balance Sheet (Total Assets: \$2,227,735)
 - 1. Operating Fund (01): \$209,905. This includes the Reserve Fund, valued at \$116,568.
 - 2. Temp. Restricted Fund (02): \$254,215. This includes Bequests of \$61,671.
 - **3.** *Endowment Trust (03):* \$461,466. The Endowment Trust Loan (balance of \$256,543) is both an asset for the Endowment and a liability for UUSS.
 - **4. Property and Equipment Fund (04):** \$1,302,150. This includes both the land and building (\$1,231,698) and the Capital Outlay Fund (\$71,912).
 - **5. Building Fund (05):** \$0

Five Star Bank loan: \$113,577 (\$3,433/mo./\$41,200/year; at 5.25% principal & interest). This is the balance as of July 31, Balance is now \$0.00

Endowment Trust loan: \$256,543. (1% interest-only loan; \$654/quarter, which is \$2,617 per year).

E. NOTES

- 1. We received a total of \$140,019 from the IRS for our Employee Retention Tax Credit in August.
- 2. We received \$102,310 as a bequest from Richard Hayden in August. Mr. Hayden also left UUSS 10% of his living trust, which is still being probated but may eventually total as much as \$150,000.
- **3.** After UUSS received the funds from the IRS, the treasurer **PAID OFF THE MORTGAGE** on September 9!!
- **4.** The Treasurer and the Finance Committee regularly monitor UUSS reserves and reserve ratio. The reserve amounts and reserve ratio have not changed in several months, and we do not recommend any adjustments currently.
